

DAGGETT COUNTY RESOLUTION NO. 14-13
A RESOLUTION ESTABLISHING PAYOFFS AND RUN
REIMBURSEMENTS FOR THE COW COUNTRY
RANCH RODEO

WHEREAS, Daggett County holds an annual Cow Country Ranch Rodeo; and

WHEREAS, contestants compete in various events and qualify for payoffs based on their placement in the events; and

WHEREAS, it has become evident that a resolution is needed to facilitate the timely payment of these payoffs;

WHEREAS, it is also apparent that a resolution is needed to establish the compensation level to be automatically paid out for stock runs, without requiring county commission approval.

BE IT THEREFORE RESOLVED by the Daggett County Board of County Commissioners that:

Section 1. Resolution

A. Payoff percentages

- i. Overall winners for each division are paid at the the same rate; 1st – 50%, 2nd – 30%, 3rd – 20%
- ii. Individual events, not part of a division, are paid at the same rate; 1st – 50%, 2nd – 30%, 3rd – 20%
- iii. The above payouts will represent 100% of money received through entry fees.
- iv. Payouts of added money, or donations received in addition to entry fees, will be determined at the end of the rodeo by the Cow Country Ranch Rodeo Committee Chairman.
- v. Payouts are all cash payouts at the end of the rodeo.

B. Stock runs/payout

- i. Stock is donated, no fees are paid out unless an animal is injured or killed due to use in the rodeo.

- C. In the case of injury or death of a stock animal:
 - i. A quote from the stock contractor will be provided and will go to the Daggett County Commission for approval and payment. The quote will be based on Fair Market value at the time of the rodeo.

- D. Gate Money
 - i. All gate money will be deposited into Daggett County for injured or hurt animals or for expenses for upcoming years.

- E. Money held in County Accounts
 - i. In the event the Cow Country Ranch Rodeo obtains insurance on its own, such that affiliation with Daggett County becomes unnecessary, and the Cow Country Ranch Rodeo is able and decides to proceed without reliance on Daggett County for insurance purposes, all remaining funds that have been deposited into money accounts held by Daggett County or any equipment or products purchased by Daggett County for the benefit of the Cow Country Ranch Rodeo using funds obtained through the Cow Country Ranch Rodeo or the efforts of its volunteers or employees will be dispersed to the Ranch Rodeo Committee Chairman at such time.

Section 2. Effective Date

This Resolution shall be effective upon date of adoption.
