

**DAGGETT COUNTY RESOLUTION NO. 14-12**  
**A RESOLUTION ESTABLISHING PAYOFFS AND RUN**  
**REIMBURSEMENTS FOR THE COW COUNTRY JUNIOR RODEO**

**WHEREAS**, Daggett County holds an annual Cow Country Junior Rodeo (“CCJR”) Series; and

**WHEREAS**, contestants compete in various events and qualify for payoffs based on their placement in the events; and

**WHEREAS**, it has become evident that a resolution is needed to facilitate the timely payment of these payoffs;

**WHEREAS**, it is also apparent that a resolution is needed to establish the compensation level to be automatically paid out for stock runs, without requiring county commission approval.

**BE IT THEREFORE RESOLVED** by the Daggett County Board of County Commissioners that:

**Section 1. Resolution**

A. All payoff percentages will be determined in accordance with the CCJR financial plan, under the direction of the CCJR Committee, who will make the final determination on all payoff amounts. The CCJR Committee shall have the right to adjust the financial plan, including any payoff amounts and percentages, without the subsequent approval of the Daggett County Board of County Commissioners. The current payoff percentages are as follows:

One hundred percent (100%) of all entry fees for any specific event shall be paid out to the winners of that event as follows:

i. Events with 5 contestants or less shall be paid as follows:

1<sup>st</sup> place – 60%; 2<sup>nd</sup> place – 40%

ii. Events with 6 to 10 Contestants shall be paid as follows:

1<sup>st</sup> place – 50%; 2<sup>nd</sup> place – 30%; 3<sup>rd</sup> place – 20%

iii. Events with 11 or more contestants shall be paid as follows:

1<sup>st</sup> place – 40%; 2<sup>nd</sup> place – 30%; 3<sup>rd</sup> place – 20%; 4<sup>th</sup> place – 10%

B. Stock providers shall be paid \$2.00 per event per stock run.

C. In the event the Cow Country Junior Rodeo obtains insurance on its own, such that affiliation with Daggett County becomes unnecessary, and the Cow Country Junior Rodeo is able and

decides to proceed without reliance on Daggett County for insurance purposes, all remaining funds that have been deposited into money accounts held by Daggett County and/or any equipment or products purchased by Daggett County for the benefit of the Cow County Junior Rodeo using funds obtained through the Cow Country Junior Rodeo or the efforts of its volunteers or employees will be dispersed to the Junior Rodeo Committee Chairman at such time.

**Section 2. Effective Date**

This Resolution shall be effective upon date of adoption.
