ORDINANCE #10-16

AN ORDINANCE ESTABLISHING PRIORITY CLASSIFICATION OF NOXIOUS WEEDS

WHEREAS, counties are permitted to under state law to designate noxious weeds; and

WHEREAS, it is necessary to the health, safety, and welfare of the residents and landowners of Daggett County to establish a priority classification to assist in the eradication and/or control of certain noxious weeds.

NOW THEREFORE the County Legislative Body of Daggett County Ordains As Follows:

SECTION 1. Priority Classification of Noxious Weeds.
